I the undersigned, acknowledge, appreciate, and agree that:

1. I understand there is a risk involved in the programs, or events that I am about to participate in, and they can be dangerous. This can include but not limited to the potential for permanent paralysis or death. **Kayaking, Canoeing, Rafting, SUP, Swimming, Tubing, Camping, Hiking, Dog Sledding, Sleigh Rides, Snowshoeing Mt Biking and Garden Tours**, can be inherently dangerous due to my knowledge and personal skill level of the activity, the location of the activity, movement day or night and with the use of the equipment involved in the activity.

Below is a list of some examples of inherent dangers, though it is impossible to predict every situation. GRO & POL will not be held liable for:

- a) If I get injured from falling from, off or out of GRO van or while on: a river trip, dog sledding, sleigh ride, snowshoeing, biking, and hiking tour that (**GRO & POL**) will not be held liable.
 - b) If I burn myself while: cooking, warming at the bonfire, falling into the fire, using the fire pit or camp cook stove that (**GRO & POL**) will not be held liable.
 - c) If I drown by: swimming, falling in the river, kayaking, canoeing, rafting, tubing, heart attack, alcohol or narcotics that (**GRO & POL**) will not be held liable.
 - d) If I get injured from: vehicle accident, stick in the eye, dog bite, falling tree, lightning storm, high water, high winds that (**GRO & POL**) will not be held liable
 - e) If I should suffer the loss, damage or theft of any of my clothing, gear, electronics or equipment that (**GRO & POL**) will not be held liable.
 - f) I understand that I am responsible for and liable for the cost and or the replacement of any property and/or equipment that I damage, destroy or lose belonging to **GRO & POL**.

I understand that any property and/or equipment in the **POL** Garden or camping area that is damaged, destroyed, lost or stolen by me, that I will be responsible for the cost or the replacement of the items. I will leave the garden, camping area, boats and all equipment in the same way I found it. I understand the **Camping Quiet Hours begin at 11P.M.**
3. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others, and assume full responsibility for my participation.

4. I willingly agree to comply with all terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring this to the attention of the nearest *Great River Outfitters or Path of Life Garden official immediately*.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS Great River Outfitters and the Path of Life Garden in Windsor Vermont**, its officers, officials, agents and/or employees, other participants, *sponsors*, advertisers, and, if applicable, owners and lessors of premises used to conduct the event (RELEASEES), from any and all claims, demands, losses, and liability arising out of or related to any **INJURY, DISABILITY OR DEATH** I may suffer, or loss or damage to person or property, **WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE**, to the fullest extent permitted by law.
